MEMORANDUM OF AGREEMENT BY AND BETWEEN THE INDIANA HARBOR BELT RAILROAD AND ITS EMPLOYEES REPRESENTED BY THE UNITED TRANSPORTATION UNION (y) IN CONNECTION WITH THE RE-ESTABLISHMENT OF SOO LINE (SOUTHEASTERN DISTRICT) ROAD CREW(S) SETTING OUT COAL AND PICKING UP COAL EMPTIES AT BLUE ISLAND YARD, LOCATED AT RIVERDALE, ILLINOIS.

Whereas the Indiana Harbor Belt Railroad Company has again requested that the Soo Line (Southeastern District) road crew(s) be allowed to set out coal and pick up coal empties at the Blue Island Yard located at Riverdale, Illinois, the following is hereby agreed to:

I. Westbound Soo Line (Southeastern District) road crew(s) may set out coal cars (loads) at the Blue Island Yard located at Riverdale, Illinois. The coal cars (loads) originate at Terre Haute, Indiana, and are destined to Inland Steel, an industry on the Indiana Harbor Belt Railroad.

NOTE: Westbound Soo Line (Southeastern District) road crew(s) shall set out the coal cars (loads) at the Blue Island Yard in the minimum number of tracks required to hold the coal cars (loads).

II. Eastbound Soo Line (Southeastern District) road crew(s) may pick up coal cars (empties) at the Blue Island Yard, located at Riverdale, Illinois. The coal cars (empties) are returning from Inland Steel, an industry located on the Indiana Harbor Belt Railroad Company, for movement to Terre Haute, Indiana.

NOTE: Eastbound Soo Line (Southeastern District) road crew(s) shall pick up the coal cars (empties) at the Blue Island Yard on the minimum number of tracks required to hold the coal cars (empties).

III. Except as otherwise provided for in Articles I and II hereinabove, Soo Line (Southeastern District) road crew(s) shall not pick up or set out enroute on the Indiana Harbor Belt Railroad Company.

IV. Except as modified herein, all Agreements between the IHB and UTU(T) are in full force and effect.

V. This Agreement and the provisions contained herein shall terminate without notice at 11:59 PM, on February 28, 1993, unless extended by mutual agreement by and between the parties signatory hereto.

VI. This Agreement shall become effective March 1, 1992, and shall remain in effect subject to the provisions of Article V, contained hereinabove.
