- Example 1:** Yardman, ID #7110, has an employment date as a Yardman with the Carrier on 11-03-65. He has accumulated 379 months of service as a Yardman. Therefore, he shall not be furloughed from 6-01-97 through and including 12-31-2028.
- Example 2:** Yardman, ID #7498, has an employment date as a Yardman with the Carrier on 6-29-70. He has accumulated 324 months of service as a Yardman. Therefore, he shall not be furloughed from 6-01-97 through and including 5-31-2024.
- Example 3:** Yardman, ID #7027, has an employment date as a Yardman with the Carrier on 12-13-73. He has accumulated 282 months of service as a Yardman. Therefore, he shall not be furloughed from 6-01-97 through and including 11-30-2020.
- Example 4:** Yardman, ID #7160, has an employment date as a Yardman with the Carrier on 3-26-77. He has accumulated 243 months of service as a Yardman. Therefore, he shall not be furloughed from 6-01-97 through and including 8-31-2017.
